## **Red 5 enhances its Board with the appointment of highly respected global mining executive Peter Johnston as non-executive Director**

*This appointment, following the recent addition of Russell Clark as non-executive Chair on 1 July 2023, adds further significant mining and governance capability to the Red 5 Board of Directors*

Red 5 Limited (ASX: RED) (**Red 5** or the **Company**) is pleased to announce the appointment of highly regarded mining executive Peter Johnston to its board as a non-executive Director, effective from 10 July 2023.

The appointment of both Peter and Russell is part of an ongoing renewal of the Red 5 Board as the Company embarks on its next chapter of growth as a leading mid-tier Australian gold producer focused on its flagship King of the Hills (KOTH) gold mine in Western Australia.

### **Non-Executive Director appointment – Mr Peter Johnston**

Mr Johnston is a highly experienced Australian mining executive and Board Director who has more than 35 years of operational and project development experience. Mr Johnston's distinguished career has seen him hold senior roles with major resource companies including Head of Global Nickel Assets for Glencore, Managing Director and Chief Executive Officer of Minara Resources and Executive General Manager at WMC Resources for Olympic Dam, the Nickel Division and the Copper and Fertilisers Division.

Mr Johnston is currently Chair of Jervois Mining and Non-Executive Director of NRW Holdings and Tronox (US). He is the former Non-Executive Chair of the Minerals Council of Australia, Chairman of the Chamber of Mines of WA and held previous long-term NED roles with Silver Lake Resources and Emeco. He is a Fellow of the Australian Institute of Company Directors (AICD) and of the Australasian Institute of Mining & Metallurgy.

Commenting on the appointment, Red 5 Chair, Mr Russell Clark, said:

*"Having only recently joined the Red 5 board as Chair, it is my great pleasure on behalf of the Company to welcome Peter Johnston, who joins the Red 5 board as a non-executive Director as part of our ongoing board renewal process.*
