COMPLETION OF SHARE PLACEMENT

We advise that settlement of the second tranche of the share placement announced by Red 5 Limited (Company) on 4 December 2009 has been completed. The Company has issued 192,000,000 ordinary fully paid shares at a subscription price of 15.5 cents each to institutional and sophisticated investors through Petra Capital Pty Ltd and Southern Cross Equities Limited, for gross proceeds of \$29.76 million.

The second tranche of the placement was approved by shareholders at a general meeting held on 21 January 2010.

In accordance with ASX Listing Rule 3.10.5, please find enclosed an Appendix 3B in relation to the second tranche of the share placement.
